



### New Strategic Plan offers 'world-class' vision 新策略性發展計劃倡議「世界級」願景

A newly launched vision for development further establishes the identity of CityU as a world-class university. *The Strategic Plan 2020–2025: World-class Research and Education* spotlights the evolution of CityU's vision by building on and advancing the aspirations embedded in the University's previous two strategic plans: 2010–2015 and 2015–2020. The new Plan's five key interdisciplinary research areas – One Health, Digital Society, Smart City, Matter, and Brain – will facilitate these aspirations.

城大為未來發展訂立新願景，進一步奠定其世界級大學的地位。《2020–2025 年策略性發展計劃：世界級研究與教學》延續並擴展 2010–2015 年及 2015–2020 年兩個策略性發展計劃的志向，進一步為城大訂立世界級願景。為達致這個目標，新策略性發展計劃訂出了五大主要跨學科研究領域：健康一體化、數碼化社會、智慧城市、物質科學與腦科學。



## Named Professorship Scheme promotes excellence in research and professional education

### 冠名教授席計劃推動卓越研究和專業教育

Named Professorships represent the highest honour that a university can bestow upon its academic staff. Its aim is to promote education and research advancement for the benefit of society. Thanks to the magnanimous donations, CityU has established 20 Named Professorships in the University's distinguished research areas. Eighteen professors were offered named professorships appointments in the fields of architecture, behavioural and policy sciences, biomedical sciences, data engineering, e-Learning, energy and environment, finance, information engineering, international economics, IT innovation and management, materials science, media art, nanomaterials, neuroscience, nuclear engineering, One Health, science, and translational neuroscience.

### CityU-Learning — Creative response to learning challenges

#### CityU-Learning — 以創意應對教學挑戰

Despite the Covid-19 health crisis, it was business as usual at CityU. Within hours of universities closing in Hong Kong because of the pandemic, the University set up a team for campus-wide online learning in real-time. Within days, the students had migrated from face-to-face classes to the new CityU-Learning platform. The creative deployment of CityU-Learning also included taster courses for secondary students and the new BOLD Forum initiative, which broadens the parameters of mass online education.

## Generous donation from Dr Harry Banga and Mrs Indra Banga bolsters the integration of art and technology

Over the past few years, CityU has continued to leverage its unique strengths to promote the integration of art and science through cross-disciplinary exhibitions that engage the community. CityU's endeavours were recognised by Dr Harry Banga and Mrs Indra Banga, two of the most successful business figures in Hong Kong from The Caravel Group, who made a donation to support the promotion of art-technology integration and the long-term development of the CityU Exhibition Gallery. The Gallery was named the "Indra and Harry Banga Gallery" in appreciation of the support and generous donation from Dr and Mrs Banga. It is hoped that the initiative of integrating artistic and technology-rich elements will help nurture the humanistic imagination and creativity of students and the public.

**Gift from much-cherished benefactor endorses HKIAS mission**  
**城大獲已故摯友捐贈 支持香港高等研究院發展**

The estate of one of Hong Kong's most influential figures made a significant donation to CityU. A HK\$15 million gift from the late Dr Chung Sze-yuen, GBM, JP (1917–2018) will be used to establish the Sze-Yuen Chung Fund in support of the Hong Kong Institute for Advanced Study (HKIAS). The HKIAS provides a platform for pursuing curiosity-driven ideas and studies, and its unfettered research contributes to the advancement of knowledge and the betterment of humanity. The bequest will help CityU recruit and retain top-notch scholars and promising early-career talent, enabling them to explore new horizons of knowledge and further expand academic and knowledge frontiers.

### Interdisciplinary research to tackle Covid-19 跨學科研究 應對新型冠狀病毒

The novel coronavirus has created an unprecedented public health crisis. Researchers at CityU from fields as diverse as veterinary medicine, biomedical sciences, data science and building technology are playing an important part in combating the coronavirus by contributing their interdisciplinary research skills to find solutions such as public health strategies and measures for preventing the spread of the virus, thereby protecting people and saving lives.

## The magic of merging art and technology

### Cutting-edge Gallery set to scale new heights

CityU is home to one of the greatest galleries in the city. For members of the public who have visited it, the University's Indra and Harry Banga Gallery is truly a hidden treasure in the city's art space.

What makes the Gallery stand out is perhaps its ability to merge art, science and technology with cutting-edge applications, such as virtual reality, augmented reality, 3D virtual imaging and modelling, and motion-capture technology, to name a few; integrated into the Gallery's exhibitions, these provide visitors with a variety of experiences that many would never have imagined. This was best demonstrated by the award-winning *ANiMAL: Art Science Nature Society* exhibition in 2018 and the *Leonardo da Vinci: Art & Science, Then & Now* exhibition in 2019, of which some original drawings by Leonardo were brought to Hong Kong for the first time.

"The Gallery made use of technology to make possible the visitor's contemporary response to Leonardo da Vinci," said Dr Isabelle Frank, Director of the Gallery. "The fact that we use technology to provide information and context for his drawings makes all the difference, with films and 3D models as interactive information screens."

Ms Catherine Kwai, Founder and Managing Director of Kwai Fung Hin Art Gallery who is also the Chairperson of the Advisory Committee of the Gallery and member of the CityU Court, said, "The Indra and Harry Banga Gallery is unique in combining art and technology in innovative ways, which is excellent for nurturing a greater appreciation of art among students and the public." The Advisory Committee, established in January 2020, comprises some of the most ardent advocates of art and culture, whose expertise and resources will contribute to the development of the Gallery. Mrs Indra Banga is the Honorary Chairperson of the Committee.

The Gallery also provides exhibition opportunities for young local and overseas artists, along with students, alumni and faculty of the University. One example of this was the exhibition *On the Road: Young Media Artists in China* in 2018.

Looking ahead, Dr Frank has plans to make the exhibitions virtual to appeal to a much larger audience in Hong Kong and beyond.

Professor Matthew Lee, Vice-President (Development and External Relations), takes pride in the fact that the Gallery takes advantage of the strengths of the University to stage technologically innovative presentations that directly engage the community. He is thankful for the support and advice of donors and art professionals, in particular Dr and Mrs Banga. "Their support is recognition of the success of the Gallery and serves as a strong impetus to us," said Professor Lee. "Thanks to the valuable donations and wide community support, the Gallery is reaching new levels of development and success."



Dr Harry Banga, Founder, Chairman and Chief Executive Officer of The Caravel Group, as well as member of the CityU Court and Honorary Patron of the CityU Foundation, said he was particularly impressed by the University's contribution to harnessing technology and bringing culture and art to the people of Hong Kong, while also playing an active role in preserving cultural heritage and driving innovation.



## 完美融合藝術與科技

### 般哥展覽館邁向新高

城大擁有香港屈指可數的其中一間最優秀的藝術展覽館；相信凡曾經到訪城大「般哥展覽館」的人，都會覺得它是深藏於香港藝術園林中的一件珍寶。

般哥展覽館之所以不同凡響，也許在於它能夠將藝術、科學、技術融為一體，它運用了多項尖端科技來呈現嶄新的藝術展示方式，略舉數例，就有虛擬實境、擴增實境、3D 虛擬成像及建模，以及動作捕捉技術等，為觀眾帶來與別不同、超乎想像的體驗。2018 年舉辦的獲獎主題展覽《動物大觀園》，以及 2019 年舉辦、首次於香港展出達文西手稿真跡的《達文西·藝術與科學·過去與現在》展覽便是最佳例證。

般哥展覽館總監范懿莎博士說：「展覽館運用高科技來展現達文西畫作的相關資料和來龍去脈，例如把影片和立體模型用作信息展示屏與觀眾進行互動，令觀眾感受如同置身於達文西所處的時代環境。」

哈利·般哥博士是拓維集團的創辦人、主席兼行政總裁，也是城大顧問委員會成員，以及城大基金最高榮譽會長。他特別讚許城大善用先進科技將文化和藝術推廣給公眾，同時致力保存文化遺產和促進創新，貢獻良多。

季豐軒畫廊創辦人及董事總經理、般哥展覽館諮詢委員會主席，以及城大顧問委員會成員季玉年女士說：「般哥展覽館的獨特之處，在於以創新手法結合藝術和科技，有助培養並提升學生和社會大眾的藝術欣賞能力。」展覽館諮詢委員會於 2020 年 1 月成立，成員皆為熱心倡導藝術文化的人士，他們的專業知識和各類資源對展覽館的發展將大有助益。般哥博士的太太 Indra Banga 女士是該委員會的榮譽主席。

展覽館亦為香港和海外的年輕藝術家，包括城大的師生及校友，增添了展出作品的機會；其中的一個例子，就是 2018 年舉辦的《在路上：中國青年媒體藝術家》展覽。

展望未來，范博士計劃將更多展覽虛擬化於網站展出，藉以吸引更多香港和外地觀眾的關注。

城大副校長（發展及對外關係）李國安教授指出，展覽館善用城大優勢，藉著創新科技呈現藝術，並與社區互動，對此他引以自豪。他感謝捐贈者和各藝術專家的支持和建議，特別是般哥博士伉儷。李教授說：「他們的支持肯定了展覽館的成功，並進一步推動展覽館的發展。有賴各方的慷慨捐贈和廣泛的社會支持，般哥展覽館將邁向新高。」

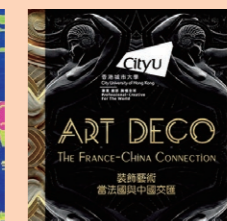
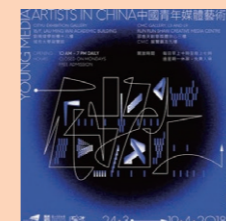

# 80% of participants in immersive-visualisation project show increase in empathy

When CityU launched the Jockey Club Enhancing Youth Empathy Project through Immersive Visualisation (the Project) in 2017, Year 2 students Ng King-kwan and Michael Tam Ming-hong in the School of Creative Media (SCM) were attracted by the concept of "empathy", which was rarely featured in the rating scheme of any competitive games or projects they had previously entered. They thought it was an excellent chance to put their creativity to the test and to find out how innovation enhances youth empathy to help social inclusion.

Led by CityU and funded by The Hong Kong Jockey Club Charities Trust (the Trust), the Project utilised the University's renowned strengths in immersive visualisation technology to respond to the needs of the ethnic-minority groups, the elderly and people with disabilities, as well as nature and the environment.

The Project participants were encouraged to develop their skills through "perspective-taking" and "role-taking", and create innovative solutions that meet the challenges and problems faced by different groups.

After joining the Project, Ng King-kwan and Michael soon found themselves making multiple visits to care homes and other facilities housing older residents, with social workers and care-takers of the elderly. For about a month, they received sufficient training opportunities to allow them to learn from healthcare professionals about the harsh challenges faced by seniors, including those suffering from dementia or stroke, or other chronic diseases.

The month was a thought-provoking one for them. "Before the training, I understood little about the issues many older people must endure on a daily basis," said Ng King-kwan. He admitted getting frustrated by things as basic as communication. He had to make every effort just to speak to the older residents at the start of training.

"It also surprised me at first how quickly some of the older residents can throw a tantrum like a child for seemingly no reason at all," Michael said. "But now, thanks to communication training and multiple visits provided by the Project, we understand. We also remind ourselves frequently that it may take time for older people to process information, resulting in a delayed reaction." There has been a marked change in the young men's empathy.

They wasted no time in designing "the Interactive Projection Game", which helps elderly people with dementia maintain their cognitive skills in an entertaining and engaging way.

Ng King-kwan and Michael were not the only participants who developed greater empathy. Over 600 CityU students participated in the Project as student ambassadors or prototype developers, and more than 80 percent of them developed greater empathy through their involvement in the Project.

Professor Matthew Lee Kwok-on, Project Leader and Vice-President (Development and External Relations), said he was proud that the Project had such an impact, "The Project reached 130,000 beneficiaries, and won 15 international and local awards, and the innovative tools developed in the Project were applied by over 60 NGOs."

"Building empathy and enhancing social inclusion are long-term challenges," he added. "With the full support of The Hong Kong Jockey Club Charities Trust, we are happy that the Project has made a good start."

Ng King-kwan and Michael said they were grateful to the Trust for supporting the Project, which gave them the opportunity to receive professional advice from faculty members and professionals, as well as equipment and financial assistance. In addition to numerous visits to homes for the elderly, they made the most of opportunity to join exhibitions and competitions.

Ng King-kwan and Michael graduated from the SCM, but over the past three years through communication exchanges with less privileged community groups, older people and supporting organisations, the duo saw the real-life impact of their creation in delivering social value, and the experience helped them develop empathy for groups in need. They are presently involved in another Jockey Club funded project, CoolThink@JC. This is another chance for them to put their empathy and creativity gifts to good use – this time for a much younger audience!

## 創新方案促進社會共融

### 賽馬會「見·同理」計劃助八成參加者增強同理心

2017年城大推行「賽馬會『見·同理』計劃」(計劃)，「同理心」這一概念吸引了當時仍是創意媒體學院二年級學生的吳景鈞和譚銘航參與計劃。他們先前參加過的比賽或活動，在計分評級中罕有這一部分，他們認為這是一次難得的機會，考驗自己的創造力，同時了解創新方案如何加強年輕人的同理心，促進社會共融。

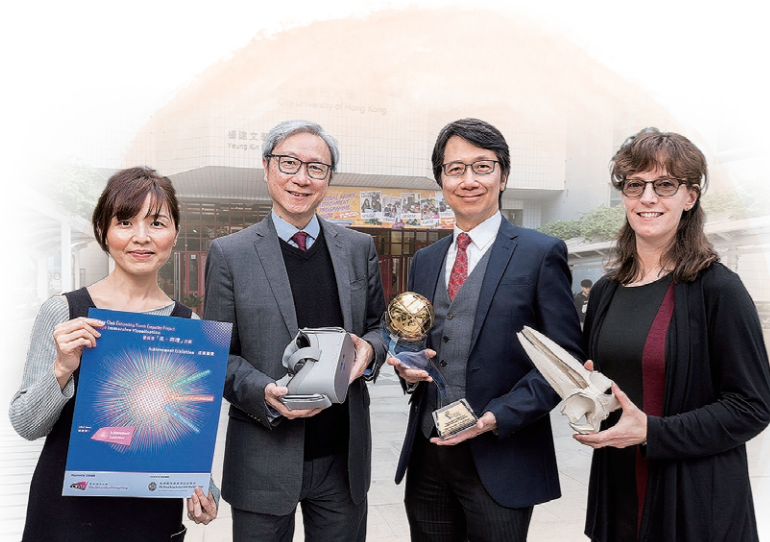
計劃由城大推行，香港賽馬會慈善信託基金(馬會)捐助，利用城大於沉浸式虛擬實境方面的技術優勢，解決少數族裔、長者及傷健人士，以及環境和自然生態所面對的問題。

計劃鼓勵參加者以「觀點取替」及「角色取替」的方式發揮他們的技能，並以創新方法協助服務對象面對挑戰及解決困難。

在參加計劃不久，吳景鈞和譚銘航便多次與社工和長者看護一起探訪老人院和其他護老院設施。在為期約一個月的探訪活動中，他們獲得充分的培訓機會，接受專業醫護人員的指導，了解到長者所面對的種種問題，包括認知障礙症、中風，以及其他慢性疾病。

這些經驗確實對他們深有啟發。吳景鈞說：「接受培訓之前，我對許多長者每天面對的困難所知甚少。」他坦承自己曾為與長者溝通那麼基本的事情而心生懊惱。在培訓初期，單是與院舍中的長者溝通就得費盡氣力。

譚銘航補充說：「起初我也感到驚訝，有些長者會像小孩一樣，似乎無緣無故輕易發脾氣。多虧計劃提供溝通培訓和探訪機會，現時我們比較理解長者。我們經常提醒自己，長者消化信息可能需要多一點時間，所以反應會遲緩一點。」兩個年輕人的同理心明顯起了變化。

他們用最短時間為患有腦退化症的長者度身訂造，設計了一套名為「耆趣遊樂園」的裝置，透過具娛樂性和互動方式，訓練他們的認知能力。

當然，因參與計劃而增強了同理心的不僅是吳景鈞和譚銘航。城大有超過 600 名學生擔任學生大使或參與設計和開發創新設備，當中逾八成人的同理心都有所提升。

計劃領導人兼城大副校長(發展及對外關係)李國安教授指出，計劃的影響如此巨大，自己深感自豪。他說：「計劃使得 13 萬人受惠，並贏得 15 個國際和本地獎項，而經計劃開發的創新工具更曾於逾 60 個非政府組織使用。」

他補充：「培養同理心和促進社會共融並非一朝一夕能夠達到，全賴馬會的鼎力支持，我們很高興看到計劃創造了一個好的開始。」

吳景鈞和譚銘航說他們很感激馬會支持計劃，不僅在設備和經濟上給予資助，而且讓他們有機會從教職員及專業人士獲得專業指導。兩人除了多次探訪老人院舍，還儘量把握機會參與展覽和比賽。

如今吳景鈞和譚銘航已從創意媒體學院畢業。過去三年，透過與弱勢社羣、長者和支持計劃的合作機構交流，他們明白到其創作所帶來的社會價值和實際影響，體會到這番經歷培養了自己對有需要人士的同理心。目前，他們正投身另一個馬會資助的計劃——「賽馬會運算思維教育」，再次有機會發揮自己的同理心和創作力，只不過這次的受眾年輕得多了！

## Named Professorship Scheme promotes excellence in research

### Nanomaterials are everywhere

Keen to create a vast range of useful unconventional materials from almost anything, one of CityU's top chemists and nanotechnology scientists is happy for others to apply them usefully for the advancement of humankind.

Professor Zhang Hua, Herman Hu Chair Professor of Nanomaterials in the Department of Chemistry, is devoted to searching for the unique properties and unconventional structures of materials at the nanoscale level.

For Professor Zhang, what is particularly interesting about nanomaterials is the fact that compared to bulk materials, their properties and crystal structures could change dramatically. To the ordinary person, they change beyond recognition, and their potential applications are widespread.

Professor Zhang can easily identify numerous applications of nanomaterials, including catalysis, clean energy and water remediation, thanks to their use in biomedicine, functionalized nanomaterials can be used as carriers to achieve targeted drug delivery and controllable release for better drug effects, in semi-conductors and electronics, and even in robotics. The list of potential uses is endless.

Professor Zhang has nearly 15 years of independent research experience in the fields of chemistry, materials science, and in particular, nanomaterials. He is a Fellow of the Royal Society of Chemistry (2014) and an Academician of the Asia

Pacific Academy of Materials (2015), and was elected Foreign Fellow of the European Academy of Sciences in 2020. He has published over 500 papers, which have caught the attention of fellow researchers in some of the world's most prestigious institutions.

In recent years, Professor Zhang has focused on the synthesis and applications of nanomaterials with unconventional phases. He is a world-known leader in the development and promotion of this unique field. He is especially proud of his paper "Phase Engineering of Nanomaterials", or PEN in short, which was published in this year's London-based *Nature Reviews Chemistry*. In his infinitely small materials world, Professor Zhang constantly sees new, imagined fields where "nothing is impossible."

In the Strategic Plan 2020–2025 released in May 2020, CityU pledges to support world-class research and education, identifying five key interdisciplinary research areas: One Health, Digital Society, Smart City, Matter, and Brain.

One can easily connect Professor Zhang's research on nanomaterials to the key research area of Matter. "Nanomaterials are one of the most key factors for the advancement of research and technology in a wide range of fields, from the environment to healthcare, and from semi-conductors to smart city," he said. "Nanomaterials are actually everywhere."

He said he is proud of the rapid progress of CityU and its achievements in world-class research, with multiple disciplines ranking among the leading institutions in the world.

Professor Zhang said he was honoured to be offered the Herman Hu Chair Professorship in Nanomaterials and thanked Ryoden Development Charitable Trust for supporting the Named Professorship Scheme. "The Scheme offers much-needed resources for research, fuelling creativity," Professor Zhang said, adding that as institutions where people exchange ideas, universities around the world need constant creativity if they are to make long-term progress.

"Thanks to the University's fundraising efforts and the generous donations from supporters, we can be sure of the continuity of cutting-edge research projects at any given time. The Scheme has allowed me to work with excellent researchers." Professor Zhang said. He wished to express his appreciation to the donors with fruitful research and contribution to CityU, society and humanity.





## 冠名教授席計劃致力推動卓越研究

### 納米材料無處不在

城大頂尖化學和納米技術科學家致力研發一系列非傳統材料，讓其他專家可以應用這些新材料來推動人類文明進步。

化學系胡曉明講座教授（納米材料）張華教授致力於探索納米世界，了解納米材料的獨有特性和非常規結構。

對張教授而言，納米材料最有趣之處，是相對於對應的塊體材料而言，其特性和晶體結構可能會出現巨大的變化，甚至超越一般人的認知範圍，且應用潛力非常巨大。

張教授解釋納米材料的應用非常廣泛，其中包括催化反應、潔淨能源和水污染處理；在生物醫藥方面，功能化納米材料可用作載體，實現藥物的靶向運輸、可控釋放，幫助發揮藥效；另外，納米材料也可廣泛應用於半導體和電子業、機械人工程等，用途數之不盡。

張教授在化學、材料科學，特別是納米材料幾個領域中，擁有近十五年的獨立科研和教學經驗。他分別於 2014 年晉身為英國皇家化學學會會士，2015 年成為亞太材料科學院院士，以及於 2020 年獲選為歐洲科學院外籍院士。至今，張教授已發表了 500 多篇論文，當中不少都贏得世界級科研同業的高度評價。

近年，張教授專注於非傳統相的納米材料的製備及應用研究。他是這個領域的領跑者，亦是重要的推動者。他對此研究工作尤感自豪，早前更於科學期刊 *Nature Reviews Chemistry* 以「納米材料相工程」（稱 PEN）為題發表論文。張教授在他的納米世界中「沒有不可能」，總能看到前所未見的新奇。

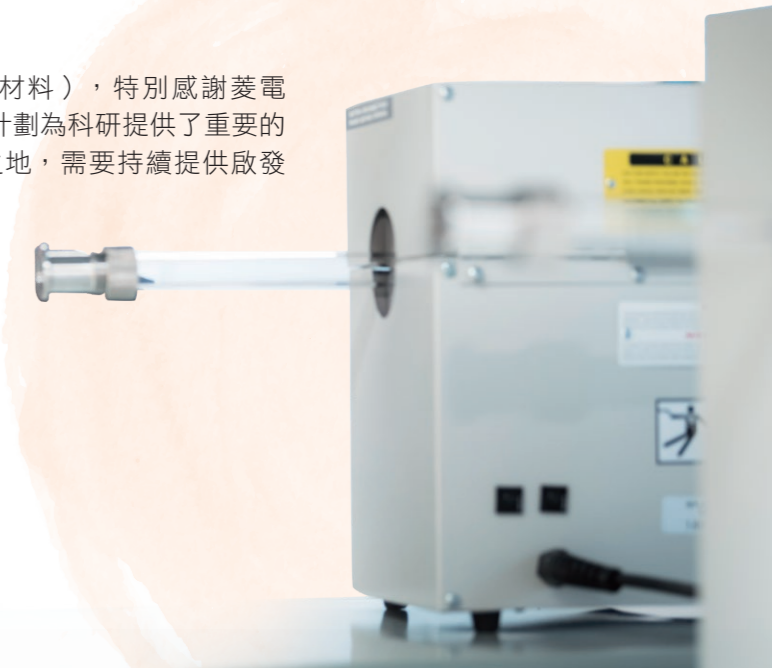

張教授的研究和「物質科學」的關係最密切，他認為納米材料是推動科研和技術進步的關鍵因素之一，其廣泛應用不但涉及環境保護與醫藥保健，還見於半導體，以至智慧城市等多個範疇。他說：「納米材料真是無處不在。」

張教授表示，城大快速進步，多個學科專業的排名更位居全球頂尖學府前列，取得世界級科研成就，對此深感自豪。

張教授非常榮幸獲委任為胡曉明講座教授（納米材料），特別感謝菱電發展慈善基金大力支持冠名教授席計劃。他說：「計劃為科研提供了重要的經費，支持知識創新。」他認為大學是學術交流之地，需要持續提供啟發創意的空間，才会有長遠的發展。

「全賴大學在籌款工作上的努力和善長的慷慨捐助，讓我們的團隊可同時進行多項研究。冠名教授席計劃使我能夠羅致優秀的研究人員，共同為前沿的研究項目工作。」他希望以科研成果回饋善長的支持，並貢獻城大和社會，推動人類文明發展。

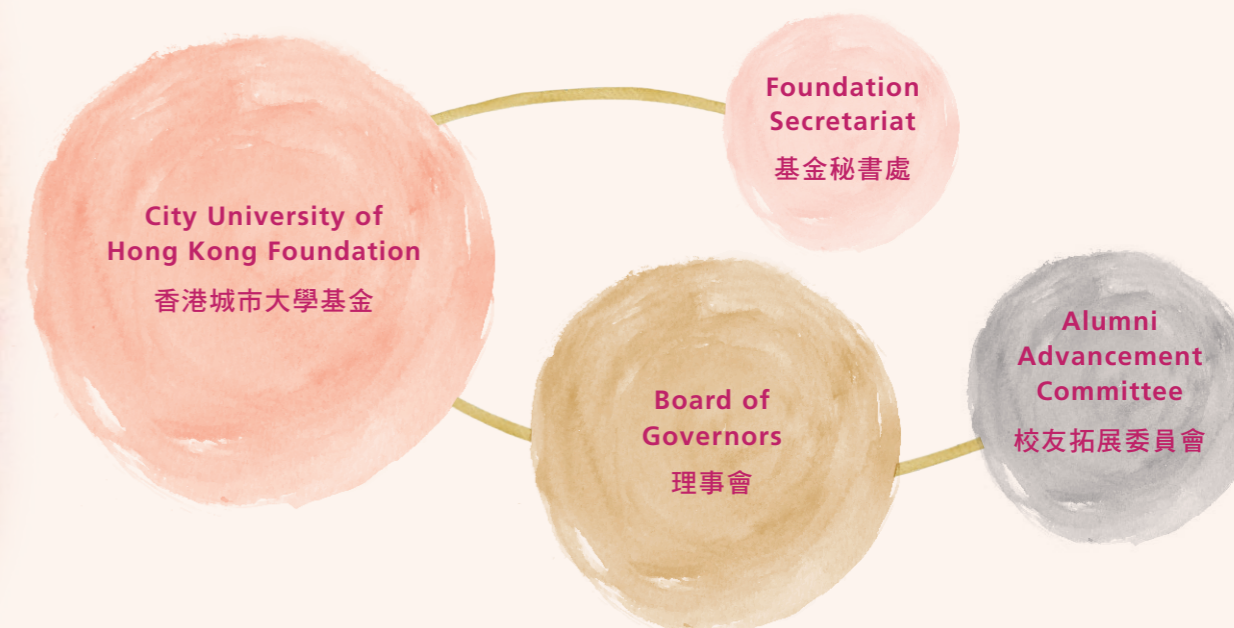
