



SOUTHEAST ASIA RESEARCH CENTRE ANNUAL REPORT 2003

The Southeast Asia Research Centre (SEARC) was a part of the Faculty of Humanities and Social Sciences at the City University of Hong Kong. It was inaugurated in February 2001, and since then, Professor Kevin Hewison (Department of Applied Social Studies) has been Director of the Centre. Dr Vivienne Wee (Department of Applied Social Studies) is Associate Director.

The Centre has established a fine international reputation, produced a range of important publications, and enhanced academic debate at CityU through seminars and international symposia.

MISSION AND OBJECTIVES

SEARC's **mission** is to develop and maintain a world-class research centre in Hong Kong for the study of contemporary Southeast Asia. The Centre's **aim** is to make new and valuable contributions to Southeast Asian studies, establishing CityU as an internationally recognised centre of excellence in this field.

The **objectives** of SEARC are:

- To develop an internationally significant research program on Southeast Asia
- To produce high quality academic publications on Southeast Asia
- To establish mutually beneficial links with international researchers and institutions studying Southeast Asia
- To promote and enhance the study of Southeast Asia in Hong Kong and to increase understanding of Southeast Asia within the CityU and among the general public in Hong Kong

RESEARCH GRANTS

SEARC researchers have been successful in gaining external funds.

Kevin Hewison's application, with Catherine Chiu and Bill Taylor, for a Competitive Earmarked Research Grant (CERG), was approved in 2003. The project, 'Hong Kong Investment and Labour Strategies in Thailand, Cambodia and Vietnam' received funding of HK\$711,000. In 2003, a further two CERG applications were submitted by SEARC core members. Both applications developed from SEARC's research programmes.

The collaborative project on labour and migration with CAPSTRANS (the Centre for Asia Pacific Social Transformation Studies), Wollongong University (Australia) was completed in 2003. It resulted in two conferences and substantial publications, including a special issue of the SSCI-listed



Journal of Contemporary Asia, accepted for publication in 2004. Collaboration was funded by CAPSTRANS, SEARC and an Australian Research Council Linkage – International Award.

Vivienne Wee's successful application for HK\$120,070 to the Japan Foundation will support the project 'China and Southeast Asia: New Regional Configurations of Capital, Labour, Ethnicity, and Space'.

Work continued on five CityU-funded research projects related to the Centre's work. These included projects on labour, Southeast Asian political economy, Thailand and China-Southeast Asia relations.

RESEARCH OUTPUT

The Centre's core academics and research staff continued their productivity in 2003, with a range of high quality publications and participation in important academic conferences. These outputs are detailed in this report's inserts.

The RoutledgeCurzon/City University of Hong Kong Southeast Asia Series, edited by Kevin Hewison and Vivienne Wee, has progressed well. The series has accepted five proposals, with two books now published. These are:

- Andrew Brown, Labour, Politics and the State in Industrialising Thailand.
- Kanishka Jayasuriya (ed.), Asian Regional Governance: Crisis & Change

Two works are in production, and another will be delivered shortly:

WORKING PAPERS

The Centre's Working Papers Series has been very successful. By December, 57 papers were available for free download, with more than 7,000 page hits in 2003.

OUTREACH

The Centre has generated much local, regional and international publicity. Core members and research staff have been interviewed and quoted in the press on Southeast Asian affairs and issues. The range of outlets includes: Asian Wall Street Journal, Far Eastern Economic Review, International Herald Tribune, The Financial Times, South China Morning Post, Associated Press, Reuters, CNNi, BBC, Star TV, and Chinese-language and Southeast Asian-language newspapers and magazines.

APPLIED WORK

Stephen Frost was involved in projects evaluating NGO labour activities and training in China, Bangladesh, Indonesia, Sri Lanka and Thailand. Vivienne Wee continued her work in gender training for the Hong Kong Government.

COLLABORATION

The Centre has a number of productive collaborative activities with other institutions. These include: Murdoch University, Griffith University and the University of Wollongong (Australia), The Institute of Social Studies (Netherlands), Universiti Sains Malaysia and University of Malaya, the National University of Singapore, Xiamen University (China), Chulalongkorn University (Thailand) and Universitas Sam Ratulangie (Indonesia).

Highlights of this collaboration included:

 Joint workshops/conferences with Murdoch University's Asia Research Centre and the Centre for Asia Pacific Social Transformation Studies at Wollongong University, both of which will result in significant journal publications in 2004-05.

• The second volume in the Translation Series on Southeast Asian Studies, with Xiamen University's Centre for Southeast

Asian Studies. This was 當代 東南亞政治研究指南 (Dictionary of the Modern Politics of Southeast Asia), by the late Michael Leifer.

• A visit to CityU by the Dean of the Faculty of Social and Political Sciences at Universitas Sam Ratulangie, with ten other academics.



EVALUATION

The performance of the Centre has been internationally competitive. A benchmarking exercise indicated that SEARC's eight core researchers produced 26 peer-reviewed publications (books, book chapters and papers in refereed journals) in 2002. This was a superior performance when compared with the two international research institutions (one in Asian and the other in Europe) chosen for comparison with SEARC, despite the fact that both included only full-time researchers, whereas SEARC includes five researchers with full teaching duties.

2003 research outputs are not as numerous as in 2002, but have been high quality. The reduction in quantity is due to the combined impacts of reduced funding, the SARS outbreak and the beginning of a new cycle of research that will yield outputs from 2004. By any measure, SEARC continues to make an impressive contribution to CityU's international and research profiles.

In 2004, the Centre will continue its research in the following broad areas:

- Labour, Migration, Regionalisation and Globalisation
- Faultlines in Southeast Asia: Religion, Ethnicity and Conflict
- Post-Asian Crisis Political Economy: Wealth and Conflict
